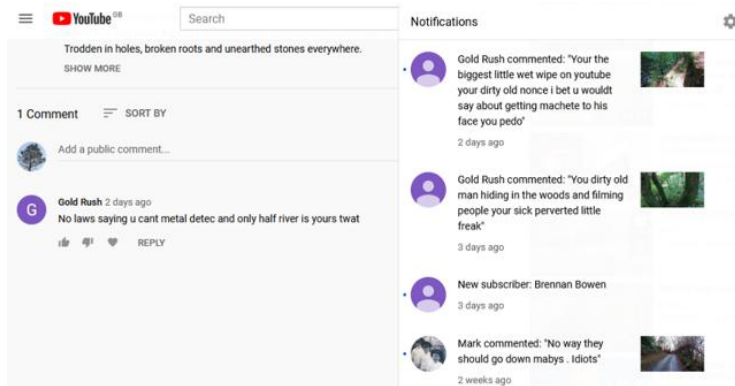

## Dyfed Powys Police Response to Crimes Listed

Firstly, the police refuse to enforce my absolute right, despite asking them multiple times:

**Protocol 1 Art.1 of the European Convention on Human Rights provides: (1) Every natural or legal person is entitled to the peaceful enjoyment of his possessions**

Police turn up on a few occasions, but not for *our* protection. **Inspector ‘Owen’ 85765 [lied]** and **Sgt Celt Thomas** (below) who was not introduced covertly filmed my wife and I at the back door, a “very sly individual” she claimed. They were here for their friend and colleague Sgt [REDACTED], NOT us, doing their best to catch us out, lie and be-little us.



**PCSO Charlotte and Sgt Thomas** turned up together to catch me out to protect their friends, again recording on private property without telling me. Sgt Thomas lied blatantly (recorded) in favour of his colleague and friend the Defendant Police Sgt. about the threats to kill. Totally corrupt.



They both claim to be 'mental health experts' actually knowing exactly what I "needed" (recorded) with suggestions of places to visit.

Yet again we were far too agreeable with these deceitful police and their lies.



**PCSO Charlotte** turns up (above).

Bizarrely requested several times for the cctv covering my land/drive/gate be redirected somewhere else whilst recording in my outbuilding without telling me.

Suspect her friends don't like their criminal activities being recorded by cctv installed solely due to their threats of killing, knife carrying, etc.

She collected my video of the threats to kill and videos of the masked Sgt standing at the gate. **To use against me.**

Asker her several times "when is this going to end?"

**PC Freeman** made contact, deciding the fully recorded textbook case of 'Harassment with Threats of Violence' by a masked up Police Sgt was in fact just "[REDACTED] passing by".

**Sgt Celt Thomas** threatened me in writing with “**serious action**” if I continue to film/photograph his friends committing illegal activities on my land whilst standing on my land.

To which end, **Sgt Celt Thomas contravened Section 26 of the Criminal Justice and Courts act 2015**

“.. the exercise of a power or privilege for the purpose of achieving a .. benefit [Sgt █████, PCO █████ and PCSO █████] or [and] detriment for another person [myself], and that a reasonable person would not expect the power or privilege to be exercised for the purpose of achieving that benefit or detriment.”

**Again, this is very serious**, yet the Police Standards Department and the Assistant Chief Constable found no reason for concern and I must accept things the way they are.

Dyfed Powys Police have done nothing about the crimes listed above. I have asked [by email] every police person that I've had contact with, including the Commissioner and Chief Constable, details of outcomes. No replies.

It would be fair to say Dyfed Powys Police actively participate and encourage the abuse of law abiding Old Age Pensioners such as my wife and I.

**“As the law abandons the Victim,  
so shall the Victim abandon the law”**

“you can’t go identifying people like this”

What the fuck should elderly law-abiding people that want to be left alone do?

This is our only option to stop this.

The police are of no use to law abiding people.

There is no way we would ever ask for Police assistance again.

**“There is no situation the police cannot make worse”**

Conversely, we would never assist the Police in any way.

The police are the enemy.

The police wish us harm and engage with unlawful activities on my land.

The police habitually lie.

The Police should reflect on this situation they themselves created.

Seven years of intense harassment continues as of 19th August 2026, making us feel very unsafe in constant fear and anxiety on our own land.
